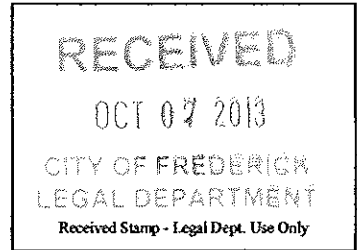





Contribution Notes:

1. 3,000 deposited from Jean Peterson Design was a refund of excess charges, not a contribution..
2. 6,000 deposited from Orases was a refund of excess charges, not a contribution.
3. 600 deposit from Maryland Democratic Party was a refund from check 1014 written in May.

These deposits were treated as an overall reduction in expenditures.

1. 5,000 from Galen Clagett is considered a loan from the candidate.
2. 2,500 deposit 6/13 was inadvertently missed on the first report, so it has been included on this one.

Expenditure Notes:

1. August bank fee amounts not known at time of first report due to the deadline falling prior to the release of the bank statement, so they have been reported on the second report.

1. Check number 1054 to Dane Corporation is a refund of an excess contribution. It was treated as an overall reduction in contributions.
