POLICE REPORT:

Cpl. Rebecca Carrado was on hand to talk about the below police statistics as well as address any issues or concerns. Residents didn't have any issues or concerns to address.

GUEST SPEAKER:

• Jenny Chen & Ron Creamer – Habitat for Humanity update

Neighborhood revitalization program will expand to 4, 5, 6, 7th street. There will be a community garden in the Restore parking lot. They are going to use water barrels to water the gardens. Habitat is also looking for areas to create pocket parks. Ron also talked about the log house on East 5th Street and said they are trying to sell it as it is too expensive to fix up. Habitat has a newsletter that they put out and it is delivered to residents in the area. • Kevin Lollar – Housing Authority

Kevin talked about the Nexus homes and said that there are 3 builders interested in finishing the project. He said that the new builder will build homes that will be the same as the ones that exist. This is a legal matter so he can't go into detail but they are hoping to start back up in April.

Kevin talked about some of the things that the Housing Authority does and is looking to do.

- They provide housing to low or no income people around Frederick. Administer 700 section 8 vouchers
- Slow down generational housing.
- o Provide young people with programs to help them get out of public housing. \
- o Rotary provides the RISE program and which teaches people how to write resumes, internships and job assistance.
- o Hope VI has changed north of 4th Street
- Housing is starting a healthy foods initiative where there will be garden plots to grow fruit and vegetables for the residents. So far Lucas Village and Carver will have them.
- o They are also teaching cooking classes
- The United Way is at the Bernard Brown Community Center and they are opening a prosperity center to help people with finances, budgeting, and taxes.
- O Working with the YMCA to bring a program back to Hillcrest
- Looking to build a new senior housing center. The current one is old. The location will be where Sharpes
 Florist is
- o Public Housing units will be smoke free and there will be designated smoking places outside. This should happen by the end of the year.
- Finish the mural on Lord Nickens Street
- Remove drug dealers from public housing

Mike Spurrier - Community Action Agency

Mike was on hand to talk to residents about The Community Action Agency. He said that they work with people that are lower income or homeless and try to improve their lives. The Soup Kitchen is open 7 nights a week and serves 30,000 meals annually. The Food bank serves 600-800 households a month and is open Monday Tuesday Wednesday and Friday. Community Action also operates a summer food service program which provides lunches to approximately 19,000 kids in the summer. They also have a backpack program for 200 students at Hillcrest Elementary. Community Action also has Outreach workers who do intakes and drive people to appointments. They operate a Healthcare program that has 2 clinics Downtown which is for adults and children, and they also have a school based health center - started back in 2009 - Hillcrest Elementary.
